



Health Requirements for All Cabrillo College Allied Health Students

In the interest of your own personal safety, the safety of your patients, and the potential liability to both the college and clinical agency, there are significant health screening requirements that must be met before the required deadlines. Each student is required to meet the following vaccination and testing requirements and provide documentation to the Student Health Center by the required deadlines. **Please note: Due to new contract requirements, proof of immunization is no longer accepted as proof of immunity.**

<i>Requirement</i>	<i>Minimum to fulfill requirement</i>	<i>OR Alternate series</i>
<ul style="list-style-type: none"> Tuberculosis screening 	Negative 2 stage TB testing within 3 months of entrance to program	1. Annual TB testing for the previous three years OR 2. If previously positive TB test, a negative chest xray report and annual negative screening questionnaire
<ul style="list-style-type: none"> Immunity to Measles, Mumps and Rubella 	Positive Rubeola, Rubella, and Mumps titers (blood tests)	If baseline entry titers are negative, the complete vaccination series will be required. The vaccine series must be in process before starting the program and completed according to vaccine timeline during program enrollment. Re-testing for immunity is required after completion of the series.
<ul style="list-style-type: none"> Immunity to Varicella 	Positive Varicella titer (blood test)	
<ul style="list-style-type: none"> Hepatitis A and B immunity 	Positive Hepatitis B titer (blood test) AND immunization record showing 2 doses of Hepatitis A vaccine	
<ul style="list-style-type: none"> Physical Exam 	Physical clearance by medical professional for physical requirements of program . Any changes in health status after physical exam (surgery, pregnancy, etc.) must be cleared by treating physician.	
<ul style="list-style-type: none"> Drug testing 	Annual Drug 10 screen for drugs of abuse utilizing secure protocol within 90 days of start of program	
<ul style="list-style-type: none"> DTAP vaccine (Diphtheria, tetanus, and pertussis) 	Immunization record showing vaccine within the last 10 years	May be waived for two years following previous Tetanus vaccine

You may elect to have these requirements performed at the Student Health Center here at Cabrillo, at your own medical provider's office, or at a clinic. Records may be brought in person to Room 912 or faxed to 831 477-5634.

Please Note: TB tests will be administered all day on Mondays and Tuesdays (closed 12-1PM) and Wednesday until 12:00PM on a walk in basis (no appointment necessary.)

All other immunizations require an appointment.

Please bring with you to the initial health requirement screening visit any records of previous immunizations. The more complete records you bring with you to the initial exam, the easier the process will be. Although SHS does not bill insurance, we can provide you with a receipt for you to bill your insurance company for reimbursement.

IMPORTANT ADDITIONAL INFORMATION

We usually schedule at least three visits to fulfill health occupation requirements. These requirements cannot be accomplished in one visit, do not expect to finish the necessary documentation in less than three months. Students providing incomplete documentation will not be admitted to clinical sites, and will not be able to meet the requirements of their programs.
