This project is to replace temporary Boiler with two new boilers with all required modifications and additions to provide a complete working system including Demolition, Concrete, Plumbing, Electrical, Controls, Restoration of all impacted finishes and Commissioning.

In accordance with California Public Contract Code 3300, successful bidder must have a **valid B Contractor license**. Pursuant to California Labor Code §1773, the Contractor and all Subcontractors performing any portion of the Work shall pay not less than the applicable prevailing wage rate for the classification of labor provided by their respective workers in prosecution and execution of the Work.
