A **Mandatory** pre-bid conference has been scheduled for **10:30:00 AM Tuesday, February 19, 2013** at the Cabrillo College Purchasing, Contracts & Risk Management Office, Bldg 2030.

In accordance with California Public contract Code 3300, Bidders must possess all of the following classifications, certifications and registrations at the time that the Contract for the Work is awarded:

California Contractors License B, with the following added:

1. "ASB" Certification
2. California Department of Industrial Relations, Division of Occupational Safety and Health (DOSH) registered contractor
3. Certified by the U.S. EPA Certification under the Toxic Substances Control Act (TSCA) Section 402 Repair, Renovation and Painting Activities (RRP) pursuant to 40 CFR Part 745.89

Contractors having endorsements, riders or qualifiers on any of their licenses such as (but not limited to) "for bidding purposes only", etc. are ineligible to perform work as part of this contract."

Pursuant to California Labor Code §1773, the Contractor and all Subcontractors performing any portion of the Work shall pay not less than the applicable prevailing wage rate for the classification of labor provide by their respective workers in prosecution and execution of the Work. Copies of prevailing wage rates may be viewed and obtained by accessing the Division of Labor Standards Enforcement databases at <http://www.dir.ca.gov/dirdatabases.html>.

Labor Compliance Program (AB 1506). The District has established a Labor Compliance Program ("LCP") pursuant to Labor Code §1771.5. The Bidder awarded the Contract shall comply with the LCP and provisions of the Contract Documents relating to implementation, compliance with, and enforcement of the LCP.

Each Bid Proposal shall be accompanied by Bid Security in an amount not less than **ten percent (10%)** of the maximum amount of the Bid Proposal.
